



PRIVACY POLICY DATA PROTECTION AND PROCUREMENT OF SERVICES

– Client Based Forms:

The resulting treatment will be to attend to Users' queries and to send them the information requested. The User's email contact details may be used to send him/her announcements and other commercial communications regarding the services offered by TRUSTED ADVISORS, provided that the parties have expressly authorized this by ticking the corresponding acceptance box. The use of the User's e-mail address under the terms indicated above will be carried out with the User's consent if the corresponding box is ticked. The data for the purpose of sending communications will be kept as long as their deletion is not requested.

The data will be kept for as long as it is necessary to deal with the User's queries and for as long as the User does not request its deletion.

– Data Used for Browsing Activities shall be treated as per the Policy on Cookies.
